CSEA Westchester Local 860 Unit 9200

Pursuant to a letter of agreement dated March 8, 2017 and signed to Joseph Castellano, Election Chair of CSEA Westchester Local 860 Unit 9200, hereinafter referred to as “Unit 9200,” and the American Arbitration Association hereinafter referred to as the “Administrator,” agreed to conduct an Election of Officers.

Two Thousand Eight Hundred Thirty-Three (2,833) ballots were mailed to eligible voters on Tuesday, May 16, 2017. CSEA provided the Administrator with a list of persons who were eligible to vote. To be counted, ballots had to be received by the Administrator no later than 9:00 A.M., on Tuesday, June 13, 2017. Forty-Seven (47) voters requested and were sent a duplicate ballot.

The Administrator received a total of One Thousand Four Hundred Six (1,406) ballot packets by the deadline scheduled. Of the packets received, Three (3) were set aside for the following reasons:

- 2-Not on List of eligible members
- 1- Set of duplicate ballots received

The number of envelopes opened was One Thousand Four Hundred Three (1,403).

The counting of the ballots took place on Tuesday, June 13, 2017, at the offices of the Administrator.

The secrecy of the ballots was maintained at all times. The results are certified to be as follows:
